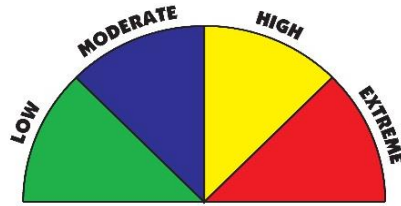

<p>Motor Vehicles including motorcycles and all-terrain vehicles, are only allowed on improved roads free of flammable vegetation, except for the cultivation and harvest of agricultural crops. In addition, each vehicle traveling on forestlands, except on state highway, county roads and driveways must have one shovel and one gallon of water or a 2.5 lb. or larger ABC fire extinguisher. Each piece of equipment must have a shovel and a 2.5 pound or larger ABC fire extinguisher.
